Wild), invites applications for the following position as public employee starting at the earliest possible date:

Heisenberg-Professorship (W2) in Translational Pathology

The successful candidate's responsibilities will include representation of the subject area of Translational Pathology in patient care, research and teaching. Applicants must have excellent scientific qualifications (habilitation or equivalent scientific achievements) and own research and teaching experience in the field of Translational pathology. You are expected to have an international track record through your research and publication activities and to have already been accepted into the Heisenberg Programme by the German Research Foundation (DFG). According to the statutes of the DFG, the professorship initially is limited to three years and then tenure can be provided after a positive evaluation by the DFG.

The candidate should be a specialist in pathology and have relevant experience in translational pathology. The professorship is associated with a leading senior medical function at the Dr. Senckenberg Institute of Pathology. Therefore, broad diagnostic expertise in clinical pathology and molecular pathology is expected. For the research field of translational, morphomolecular pathology, preferably with a focus on oncological issues of the lymphoreticular system, an expert should be recruited who can innovatively develop the scientific profile in this field and represent it in an internationally visible way. The constructive willingness to participate in already acquired projects and to establish a research focus at the location is a prerequisite. Integration into the oncological focus of the department and the University Hospital (Frankfurt Cancer Institute - FCI, University Centre for Tumour Diseases - UCT, local and national structures of the German Consortium for Translational Cancer Research - DKTK) is expected. Experience and commitment in teaching, didactic skills and the willingness to actively contribute to the teaching of human medicine and dentistry as well as other study programmes in which the Faculty of Medicine participates are also required. Active acquisition of thirdparty funding is expected.

The designated salary for the position is based on the German university pay scale or equivalent. Goethe University is an equal opportunity employer, committed to diversity and inclusion. In particular, we are welcoming applications by qualified women and people with a migrant background. At Goethe University, a special emphasis is placed on creating and sustaining a family-friendly work and research environment. Where applicants are otherwise equally qualified, preference is given to candidates with disabilities or equivalent. The same applies to women in fields in which they are under-represented.
